

## Terms and Conditions

Please read these Terms and Conditions ("Terms", "Terms and Conditions") carefully before using the <https://www.collective.gg> website and the Collective Card Game mobile application (together, or individually, the "Service") operated by Odious Studios ("us", "we", or "our").

Your access to and use of the Service is conditioned upon your acceptance of and compliance with these Terms. These Terms apply to all visitors, users and others who wish to access or use the Service.

By accessing or using the Service you agree to be bound by these Terms. If you disagree with any part of the terms then you do not have permission to access the Service.

### Communications

By creating an Account on our service, you agree to subscribe to newsletters, marketing or promotional materials and other information we may send. - Art you create using any of the Card Creator's built-in images belongs to us.
- We reserve the right to delete anything you make if it violates the submission rules, or for any other reason.

## Accounts

When you create an account with us, you guarantee that you are above the age of 16, and that the information you provide us is accurate, complete, and current at all times. Inaccurate, incomplete, or obsolete information may result in the immediate termination of your account on the Service.
